III. Approval of President's Council Minutes

The Council unanimously approved the March 24, 2009 minutes with the following amendment:

Dr. Rodriguez spoke regarding item F - Board Policy 2315 "Closed Session" lines 17-19 that "in most cases" should replace "shall".

IV. New Business

A. Accreditation Update – Dr. Rodriguez

Dr. Rodriguez announced that the Accreditation Report was completed and was submitted to the Commission. He stated Trustee Brown and Trustee Rivera reviewed the report on Monday, March 30, prior to submitting the report.

B. Donations – Dr. Stephens

Dr. Stephens was not present. Vince Brown spoke to the donations received by the college.

C. Revised Assessment Re-Take Practices – Dr. Wetstein

Dr. Wetstein spoke regarding the New Retake Policy (Additional Changes) effective May 22, 2009. He stated the multiple choice retake test for reading and math will be discontinued as well as the composition retake test. Instead, students will be allowed retesting for all subjects as COMPASS – a computer adaptive test. There are 3 sequence of tests in which a student may retest. Janice Takahashi asked if this has been taken to the Academic Senate. She stated that she would report this information to Academic Senate at her afternoon meeting. It was agreed to delay approval until after she reported the information to the Academic Senate.

D. Proposed Revision Policy 2500, Academic Senate of San Joaquin Delta College - Dr. Wetstein

Dr. Wetstein stated by adding "and procedures" and/or procedures" (lines 9-10 and 72) to the policy, this revision enables representatives of the Academic Senate to bring its concerns over both policies and procedures directly to the Board of Trustees for collegial consultation and mutual agreements. The Council approved the revisions.

E. Proposed Deletion Policy 5200.1, Credit/No Credit Grading Option to AP42301, Pass/No pass Grading Option – Dr. Wetstein

Dr. Wetstein stated that Academic Senate proposes to keep paragraph B (lines 11-16) in the policy. Eliminating the current limit on use of the P/NP (previously C/NC) raises questions of rigor and integrity, might devalue degrees awarded, remove academic incentives, and disadvantage students who apply for transfer. Academic Senate agrees to replace notation of "C/CN" with "Pass/No Pass." The Council approved the revisions.
