Following correction of minor typing error, it was agreed to forward to President's Council.

- Proposed Changes Policy 4020 "Employment Requirements"
- Proposed Adoption BP/AP 7310 "Nepotism"

The proposed adoption of BP/AP 7310 "Nepotism" and adding language from BP/AP 730 to Policy 4020 "Employment Requirements" (Classified Employees), will bring actual practice and current policy inline with the Education Code. It was suggested that other employment policies related to managers and faculty may need to be reviewed to include the new language regarding employment/supervision of immediate family members.

Agreed to forward to President's Council.

3. Comments – Management Senate and Instructional Deans Proposed Changes AP 7217 "Academic Employees"

Discussion continued on the proposed changes to AP 7217. Comments from the Division Deans were reviewed.: suggested include language "A person who is employed to teach adult or community college classes for not more than 67% of the hour per week be considered full-time employment for regular employees having comparable duties shall be classified as a temporary employee, and shall not become a contract employee under Section 87604." The Academic Senate President suggested that the language regarding 67% (manager's language) be added back to the AP and identified as "A," and move the enumerations down. In addition, the Academic Senate President suggested including the formula as applied to calculate hours of librarians and counselors, and any other 35 hour faculty, to allow ability to grievance over work load if necessary – include as "D."

Following review it was agreed to edit lines 11 and 13 strike "and adjunct faculty, amend to "adjunct counselors and other faculty" in order differentiate fixed hourly from other instructors.

It was agreed to draft item "D" (calculation), and release for member consideration via email, and forward to President's Council.

4. Returned from December 11, 2008

Proposed Deletion Procedure 5203 "Scholastic Probation and Dismissal" to BP/AP 4250 "Probation Disqualification and Readmission" - Returned from rewrite (tabled March 2006)

The Director of Admissions and Records reintroduced the proposed changes as prepared in collaboration with faculty members from Guidance and Counseling (the Academic Probation Committee). She informed the group that the Academic Probation Committee's work incorporates recommended language from the CCLC template and completely eliminates the March 2006 proposal.

It was agreed to release the proposed deletion/changes for a comment period ending March 12, 2009.

5. Board of Trustees Series 1000 Conversion Collection to Chapter 2, Board Policies, CCLC

The Executive Secretary introduced the conversion collection to the Committee and advised them that most of the policies had only been converted to the CCLC number format. He reviewed the list in detail which identified those policies that had not only

been converted to the CCLC number format, but also included recommended language from CCLC where necessary. He asked that the Committee agreed to submit the policies in the collection with only number conversion to President's Council and release those with subsequent language to for comment by the shared governance groups.
