

**ASDC MEETING**  
**Monday October 19, 2015**

The regular meeting for the ASDC was held on **October 19, 2015** at 2:34pm at San Joaquin Delta College in the Rauhuff boardroom. The President being in chair. The following members were present: Duran, Findlay, Murry, Slaughter, Medina, Soto (late-excused), Rodriguez (late-unexcused), Romero (late-unexcused), and Blaine (late-unexcused). Quorum was met.

The minutes for the October 19, 2015 meeting were approved as corrected.

Senator Slaughter moved “to approve a payment in the amount of \$69.29 to Smart and Final.” Motion approved without objection.

Senator Slaughter moved “to approve a payment in the amount of \$1,056.95 to KD Canopy.” Motion approved without objection.

Board discussed the pros and cons of the Rocktober Fest.

Board discussed International Food Fest ideas including: entertainment, decorations, and six different types of food.

Senator Blaine left the meeting at 3:24 unexcused<sup>1</sup>.

Senator Rodriguez left the meeting 3:30pm excused.

VP Findlay reviewed the Mountain House plan to the board.

Senator Murry discussed the Mustang Night flyer and announced that the food will be purchased from Pizza Guys and a sign-up sheet is available to students that want to perform.

Senator Murry moved “to approve a cash advance of \$300.00 for Mustang Night Supplies.” Motion approved without objection.

President Duran suspended the order of the agenda to discuss Reports, without objection.

Trustee Romero reported: an email will be sent out to the campus regarding the food pantry. Romero also reminded the board of the event with Associate Justice to the Supreme Court, Sonia Sotomayor UOP on Friday, October 23<sup>rd</sup>.

VP Findlay reported receiving compliments from students regarding the Rocktober Fest during her tabling hours. Students commented on how much they enjoyed the food and band, and some were interested in joining the ASDC board as well.

Treasurer Soto reported she attended the Facilities/Planning committee and during the meeting they discussed locations that will be getting service.

Director Butler reported: Shayla will be taking the ASDC cover and mascot to the dry cleaners, the cart and flatbed will now be in the back storage area in the Student Activities Office, the iPad cover was returned to purchase one with better drop protection; the ASDC brochure is currently being updated; board members were reminded to check the expiration dates when organizing the food pantry; the ASDC decals are finished, and the discount list for the mustang pass is being updated.
