Trustee Romero reported receiving a complaint from students regarding the lack of variety and healthy food options on campus and a concern with the Admissions and Records windows not all being open.

Senator Murry also reported a concern with the restrooms not being properly cleaned. Board discussed creating a petition or survey regarding the restrooms around campus.

Director Butler reported that a microwave is now available for students to use in the cafeteria; the ASDC banner will be arriving shortly; and reminded the board to review the ASDC decals."

Trustee Romero moved "to reimburse Aja Butler in the amount of \$184.86 for Food for Thought expenses." Motion approved without objection.

Senator Slaughter moved "to approve a budget not to exceed \$250.00 each month to purchase food for the ASDC office." Motion approved without objection.
